Abstract

1 Executive Summary

As a Coordination and Support Action funded by the H2020 programme and begun on May 2019, [IDIH \(International Digital Health Cooperation for Preventive, Integrated, Independent and Inclusive Living\)](#) aims at promoting and increasing international cooperation to advance digital health in the EU and key Strategic Partner Countries (China, Canada, Japan, South Korea and United States) supporting active and healthy ageing through innovation.

By pursuing the overall objective of promoting information and international cooperation among the stakeholders of Digital Health for Active and Healthy Ageing, the e-Newsletter of the IDIH project were released as Magazines of the project informing about relevant policies and initiatives, as well as publications and funding opportunities, focusing on news and articles especially addressing the international landscape for R&I in the EU and the IDIH Strategic Partner Countries.

The IDIH Magazine, available since May 2020 in a short (HTML) and a full (PDF) version, has been published on the project website and re-launched on social media channels and through partners' networks. This document aims to provide a review of the Magazine editions, also describing the methodological approach for their production. It includes descriptions of the contents of the Magazines based on the six sections through which each edition is structured, ranging from hot issues at stake in the international landscape around Digital Health & Ageing, to a selection of contributions from high level experts sharing their experiences and stories, and an overview of the initiatives and relevant opportunities for the IDIH ecosystem.

Shedding light on the literature and the initiatives concerning the Digital Transformation supporting Active and Healthy Ageing, the IDIH Magazines have been a key tool for the IDIH project communication and dissemination and to further engage IDIH stakeholders – often participating in the Magazine as co-authors or interviewees.

2 Introduction and methodology

Six e-newsletters (published approximately every 6 months) have been published throughout the IDIH project, based on the project’s website publications, a continuous monitoring of the key sources in the project domain and the participation of IDIH experts and stakeholders as co-authors and interviewees.

The magazines targeted high level stakeholders for delivering project, scientific and policy related news in an easy-to-read format through a HTML reduced version – published in the [dedicated webpage of the project website](#), from which the users could access a full PDF version.

APRE – Agency for the Promotion of European Research – has been the partner of the IDIH consortium responsible for the activities related to the production of the IDIH Magazines.

The strategy set at the beginning of the project to address the production of the IDIH Magazines has foreseen the organisation of contents in **six sections** and the dissemination through **two formats**, as follows.

2.1 The Six Sections of the IDIH Magazine

IDIH Focus On

Following the editorials from the coordinator and/or an EU policy officer and a keynote guest, this section includes significant **updates at policy level** addressing Digital Health & Ageing at international level, in the EU and IDIH’s Strategic Partner Countries, including issues and events from the international R&I landscape. A showcase that served as a mean to monitor the progress of IDIH key partner countries in the field, from both an institutional and a scientific perspective.

It differs, in this sense, from the “restricted” community of experts gathered in the Digital Health Transformation Forum.

The call for news/articles regularly invited researchers and experts to disclose their expertise to widen and deepen IDIH's dissemination.

The section highlights **key publications and project deliverables and outcomes** in the field of Digital Health & Ageing, from the EU and the Strategic Partner Countries, including research papers and innovative discoveries, redirecting to the related website sections, as well as the main events, and initiatives from the international IDIH ecosystem through project partners.




Figure 2 IDIH Magazines - Main dissemination channels

Editorial

IDIH Focus on

The following section opened with the 10 priority actions of the first ERAvsCorona Action Plan, aiming at disclosing the core institutional and policy initiatives taken by the European Commission. From the innovation perspective, a particular attention was given to the initiative of AI Alliance in facing the outbreaks of Covid-19, within the R&I initiatives, financial support to CureVac and new calls from EIC to SMEs and start-ups.

IDIH Experts' voice

From the interview with Gian Marco Revel, Associate Professor at Università Politecnica delle Marche and Coordinator of the Material & Sustainability committee of the same university, light has been shed on the state of the art of age-friendly cities, buildings and infrastructures. The section continues in examining the main challenges of digital and healthy ageing through a policy perspective by analysing the state of health in the EU and the digitalisation of health promotion, to conclude with the D4 Action Group of EIP of AHA – European Innovation Partnership on Active and Healthy Ageing.

IDIH Sharing Corner

An overview of the landscape of digital healthcare addressing Japanese ageing society opened this third section, which continued with short narratives about innovative calls and projects such as the first European hub for mobile health, the project PlatformUptake.eu, including study reports, identifying the specific needs and desiderata of users at different ages, the use of social media for health promotion, and the latest from the R&I Community, such as the first robots that can assist older people and adapt to the culture of individuals.

IDIH Resources

The chapter included a concise assessment of the IDIH Stakeholders Engagement action, which is crucial in the framework of the project and its Forum, managed through an expert-drive approach and a user's-centred perspective, through an open and collaborative environment encouraging mutual learning within the IDIH Community. A brief examination of the role and activities of the Expert Groups (EGs) and the IDIH Digital Health Transformation Forum, as well as with the Policy Makers was done, by explaining the role of the Programme Level Cooperation (PLC), to conclude with the Users associations engaged in the IDIH project in the Users Consultation Group (UCG) and updated on a regular basis on the work implemented by the EGs.

IDIH Highlights

This section contained an examination of the Calls for research projects launched by the AAL programme, within a description of the duties and tasks of the applicants. It continued by analysing the Call 2020 Healthy Aging and the necessary TRL requirements in demonstrating a clear path toward market and added value for different types of end users. The section also investigated AAL Solutions Supporting Older Adults During the COVID-19 Outbreak and described the innovations brought from several actions as for example the EIT Health New funding programmes for the internationalisation of start-up and scale up, and AgeingFit, the event dedicated to innovation in AHA.

We have also recently finalized two Guidebooks where RDI stakeholders, as well as care givers and user's associations, can find an overview of the Funding Agencies and current Programs that deal with Digital Health for AHA in Europe and may represent valuable opportunities for international cooperation in these fields. On this regard, here you will find information also regarding the upcoming funding opportunities for researchers and innovators in Digital Health and AHA in the Highlights session! I'm glad to inform you, finally, that we are preparing a series of worldwide workshops and podcasts for the new year, please stay tuned! I therefore take this opportunity, on behalf of all the IDIH staff, to wish you the best for 2021, sending our Season's greetings for the upcoming festivities.

IDIH Focus on

Addressing a main focus on COVID-19 challenges, the section examined the efforts deployed by the European Commission in building a European Health Union, within the analysis of its legislative proposals and the adoption of a new Pharmaceutical Strategy for Europe. It keeps on analysing the conclusions of the Council of the European Union concerning the human rights, participation and well-being of older persons in the era of digitalisation and concluding with crucial initiatives as the European Health Data Space.

IDIH Experts' voice

The interview with Kanoko Oishi by Sawarabi Group (IDIH Partner) underlined the crucial role played by EU and Japan and how they both take constructive advantages from their partnership. Giovanni Saggio, Professor at the Department of Computer Engineering of the University of Tor Vergata (Italy) and IDIH Chair of the Experts Group on Preventive Care – has provided his vision on Preventive Care perspectives around the themes of Wellbeing and AHA. The section ended with the European Week of Active and Healthy Ageing: a dialogue between experts and policy makers around the future of ageing societies.

IDIH Sharing Corner

Several stakeholders shared their stories of innovation, proofing their capability of bridging science & technology to real human life, such as in the case of AIST (Japan) and keeping dementia away, such as in the case of South Korean GSBC. Other articles described the living conditions under COVID-19 restrictions: the experiences of older adults and caregivers (Canada), or the new project *Next-Generation Internet of Things for innovative healthcare solutions* launched by the European Commission.

IDIH Resources

IDIH brought to the attention of the readers several essential dissemination products of this project: two guidebooks published and freely available on IDIH website concerning the RDI community (D2.1 Guidebook for RDI stakeholders) and the care givers and the user's associations who deal with digital solution for AHA (D4.5 Guidebook for Care Providers and Users). Moreover, a series of six podcasts to present the opportunities for international cooperation to the potential stakeholders in a consistent manner throughout the second part of the project life, starting from 2021, available on the IDIH website. The section concluded with reporting on the first meetings of the IDIH experts and the Users Consultation Group.

IDIH Highlights

EIT Health launched the flagship accelerator program for start-ups in Digital Health, Medtech and Biotech with the support of Health Axis Europe, allowing the applicants to become part of the EIT Health Community of world leading medtech, biotech, pharma and IT companies. Other calls concerned the Gatekeepers partner projects, Ageing Fit event, and the AAL annual forum.

Editorial

Dear Reader,

Welcome to this edition of the IDIH Magazine, an opportunity to be updated on news, opinions, opportunities and events in digital transformation in health for active and healthy ageing, with a look to the trends and perspectives of international cooperation in this field.

The EU has international cooperation activities in the area of digital health with a number of key partner countries like Japan, Canada, South-Korea, India, African countries and the USA. We can say that in the future, the international cooperation in the area of digital health will be mainly oriented at enhancing collaboration and mutual cultural understanding, e.g., regarding smart living approaches to further develop cultural adaptations, as in the ongoing EU-Japan collaboration of social robots assisting older people in fall prevention. Moreover, efforts will be put in promoting European values regarding interoperability and good governance in the sharing of health data, taking into account data privacy but also security-relevant aspects considering human rights abuses, and ensuring citizens' trust. One of the main priorities of the European Commission in the area of the digital transformation of health and care is, indeed, the creation of a common European Health Data Space (EHDS), as set out in the European Strategy for Data adopted in February 2020, with the aim of improving safe and secure accessibility of health data, allowing, thus, for targeted and faster research, diagnosis and treatment.

Horizon Europe will offer various R&I opportunities for enhancing the use of digital technologies for better health and care, to empower doctors, patients and citizens with better digital health literacy, to enhance the adoption of digital health solutions through a stronger ecosystem. In this scenario, the innovation and deployment of digital health technologies are an absolute priority. A dedicated European Partnership on Transforming Health and Care Systems would provide input for the scientific priorities, especially with regard to unmet public health needs. The international actors of R&I will have, thus, again the chance to enhance cooperation with the EU in the framework of Horizon Europe, that continues to be inspired by a general principle of openness to the world, while taking into account mutual benefits, international commitments, scientific diplomacy and reciprocity criteria.

Ageing, as a global challenge, is now a common ground for mutual learning and cooperation, and may also plenty of opportunities for economic growth, with a more prominent silver economy, technological and health innovation, and a more inclusive and fairer society for longer, healthy and meaningful lives. The Green Paper on Ageing (January 2021) adopts a whole life approach to ageing, calling for taking adequate policy actions in different domains, from improving the health and wellbeing of older people, to promoting life-long education, gender equality and civic participation of older people. Putting this in the perspective of a Green and Digital transition it is important to harness the potential of digital technologies and better digital skills for all: e.g Apps that promote healthy lifestyles from early on or help with chronic conditions; enhance the use of telemedicine and reduce hospitalizations, waiting hours or



increased risk of infectious diseases; adapt our houses, working and living spaces, communities and cities to the ageing process, also with the help of digital technologies.

With the setting up of the Horizon Europe program, this edition opened by highlighting the crucial role of this program with a thorough examination of its pillars and operational specificities. The subsection illustrated the proposal for a Regulation of Artificial Intelligence by the European Commission, reporting some useful factsheets by the European Parliament on Horizon Europe, the assessment of International Cooperation under Horizon Europe and Open Science free tools by the European Commission.

IDIH Experts' voice

“Design and Technologies to eliminate Human Loneliness” was the title of the interview with Ory Yoshifuji, co-founder and CEO of Ory Laboratories Inc. included in this section, focusing on implementing technology in helping and reducing risks for dementia and disabled people. The section also highlighted the initiative taken by the Centre for Aging and Brain Health Innovation – CAHBI (Canada) in launching the GLOBAL DIALOGUE ON TECHNOLOGY BY THE WORLD DEMENTIA COUNCIL.

IDIH Sharing Corner

This section covered that the European Commission launched the Platform “Futurium. Active and Healthy Living in the Digital World”, as part of the Forum Active and Healthy Living in the Digital World, a multi-stakeholder forum of EU to support the R&I community and initiatives related to active and healthy aging, such as the EIP Partnership on AHA and the AAL – Active and Assisted Living Program. The WHO Global Report on Ageism and Toolkit on supporting older people in facing Covid-19 pointed out the necessity of more effective strategies to prevent and respond to ageism. Information on how along with Covid-19, US-China collaboration on Covid-19 research and the EU Strategy for the development and availability of therapeutics, also enriched this section.

IDIH Week 2021, Guidebook publications and podcasts are part of this subsection, besides some opportunities for international researchers and innovators to get funded in Europe. The section deepened some aspect of information on funding opportunities for international cooperation in the field of Digital Health for AHA Policy engagement.

A renewed and reinforced cooperation between EU and the USA set the key priorities in the fields of tech and ageing thanks to the Digital Rulebook, opened this chapter, continuing with the Bio Japan 2021 exhibition and the Digital Health & AHA funding opportunities, within other relevant events on AHA.

Editorial

Dear Reader,

even though relevant key programmes and funding agencies are supporting collaboration in digital health Research & Innovation on a national and international level, there are relatively few international Science, Technology & Innovation agreements in place between the EU and Strategic Partner Countries, especially with Asia. Thus, further international demand for cross-border cooperations seems to be evident, to particularly address the challenges of Active and Healthy Ageing (AHA) with digital health solutions in a globally coordinated manner leveraging on each partners' expertise.

Through a thorough analysis of key enablers and expert consultations, the H2020-project IDIH was able to gain a clear picture depicting similar overarching challenges related to digital health for AHA (For detailed information please refer to this IDIH report D1.2) faced by the EU and the five Strategic Partner Countries under investigation – Canada, China, Japan, South Korea, and USA. While all the 6 regions are jointly facing a common challenge, namely that of an aging population, they are also confronted with similar issues such as insufficiency of essential regulatory frameworks regarding ethical and security issues on eHealth data access; highly regulative and impeding procurement systems, complex certification procedures that hinder the industrialisation of digital healthcare, the development of related start-up cultures, and hence the growth of the digital health market; and lack of necessary funding for research and development which is either not available in sufficient quantity or scattered across different funds and objectives.

The IDIH project has further identified several analogies across the EU and its Strategic Partner Countries deriving prioritized recommended areas for international cooperation in the field of digital health for AHA (IDIH report D1.3): Data infrastructure improvement and enhanced data exchange is one of the main priorities, including corresponding topics like an empowerment of citizen's through access to their health data. Interoperability standards should be another high priority issue at transnational level. Preventive care technologies and solutions supporting care at home for the elderly populations living independently will be key to relieve the health care system, along with eHealth to serve remote areas, reduce hospitalisation rate or specialist doctor's appointments.

With a view on health topics to be jointly addressed, the countries under study have recognised that a combination of Research & Innovation measures needs to be taken into consideration to alleviate the healthcare burden through ageing and support AHA for all, including (1) the understanding of the complex health challenges arising from multimorbidity of the elderly related to ageing, (2) personalised medicine for more effective, adult-centred solutions for the senior population, (3) measures for health promotion, disease prevention and care at home and (4) social challenges regarding health care and inclusion of elderly people.

With its ambition to serve as a catalyst for the international collaboration in the field of digital health for AHA, IDIH is now offering a second edition of the IDIH Week, following the overwhelmingly positive response to last year's event.

IDIH Week is a virtual four-days event dedicated to interconnect researchers, innovators, care providers and users' associations dealing with Digital Health for AHA. This year's edition of the IDIH Week is an occasion to present and discuss the projects findings and products, as well as to engage the IDIH community of experts – now counting more than 400 stakeholders gathered in this platform – in networking and open innovation sessions around Digital Health for AHA at international level. IDIH Week took place online between March 21–24, 2022 with three sessions dedicated to Information, Networking & Matchmaking, and Co-creation. A key-novelty of this 2022 edition were two Regional Workshops dedicated to the R&I landscape around Digital Health & Ageing, in the USA and Japan.

Supported by funding from the Horizon Europe Programme and the Digital Europe Programme, the European Chips Act's proposal was a watershed in the EU's policy to strengthen the Europe's technological leadership. New calls for proposals in the Digital Europe Programme as well as the EU4HEALTH 2022 Annual Work programme adoption and the Japan's state of art on ageing policies, within other narratives, were the articles of interest within this section.

IDIH Experts' voice

Peggy Maguire, Director General of the European Institute of Women's Health (EIWH), highlighted the need for gender equity in health. Giovanni Saggio, Dept. Electronic Engineering, University of "Tor Vergata", illustrated the efficiency of voice-based diagnosis in determining pathologies and other conditions analysed by Artificial Intelligence. The chapter concluded with several eCare encouraging testimonies.

IDIH Sharing Corner

Covid-19 and older people, challenging Ageism, and updates on Ageing Policies were the core issues of this subsection, which dedicated most of its analysis on assessing a comparative perspective of ageing in different EU and non-EU countries, within the study of Parkinson's symptoms and ageing policies.

IDIH Resources

The IDIH Week 2022 was presented in this section, with an update on the latest project findings and products towards the elaboration of the IDIH Roadmap to enhance international cooperation on Digital Health and Active and Healthy Ageing, highlighting how this has been approached in IDIH as an incremental knowledge co-creation process based on an expert-driven approach and a user-centred perspective, in order to favour evidence-based policies and an international policy dialogue.

The section explored several initiatives, such as the Commission publication of a Call for evidence and public consultation on standard-essential patents (SEPs), a Call for papers on resilient and responsive health system in the changing world. It concluded focusing on industry's award and tenders.

Thus, the EU aids on Ukrainian scholars is one of the milestone articles of this section, which continues with a series of articles leading to new AAL2Business initiatives and toolkits, and a [report](#) by the United Nations Office of the High Commissioner for Human Rights (OHCHR) that shed light on the enjoyment by all older persons of human rights, calling for a two-track approach: better implementation of existing norms and standards and accelerated development of a new UN convention.

3 Conclusions

The IDIH Magazines addressed the Digital Transformation supporting Active and Healthy Ageing internationally through an expert-driven approach and a user's-centered perspective, disseminating information and favoring networking and international cooperation among the stakeholders of the project.

Over the past two years, the scientific community has found itself faced with a pandemic crisis, still ongoing, that has greatly influenced even the IDIH project initiatives internationally, then redesigned as virtual and mainly re-approached also methodologically.
